U.S. Customs and Border Protection has determined that you entered the United States pursuant to Section 217 of the Immigration and Nationality Act. Accordingly, you executed a Form I-94W, Visa Waiver Program Information Form that explained to you the conditions of admission under the Visa Waiver Program. When you signed the Form I-94W, you also waived your right to contest deportability before an Immigration Judge and the Board of Immigration Appeals, and to any judicial review of the any and all of the above decisions.

U.S. Customs and Border Protection has determined that you have violated the terms of your admission under Section 217 of the Immigration and Nationality Act, on the grounds that: you entered the United States on at Port of Miami under the provisions of the Visa Waiver Program and were 10/31/2020 admitted until 01/28/2021

On the basis of the foregoing it is charged that you are subject to removal from the United States pursuant to the following provisions of law:

Section See Narrative of the Immigration and Nationality Act (Act), as amended, in that after admission as a nonimmigrant under Sections 101(a)(15) of the Act and 235.l (f)(iii) of Title 8, Code of Federal Regulations, you failed to comply with the conditions of the nonimmigrant status under which you were admitted.

Accordingly, U.S. Customs and Border Protection has entered an order that you be deported and removed from the United States.
